- DO**
 - Clean first!
 - Look for opportunities for TUR
 - Ask questions: *What are you and/or your contractors using? How are the products being used for cleaning and disinfecting?*
 - Integrate cleaning and disinfecting into “regular” operations
- DON'T**
 - Over use disinfectants
 - Mix products
- KNOW**
 - Safer options do exist
 - Cleaning and hand-washing are pollution prevention strategies
 - TURI continues to be a leader in the growing science on cleaning and disinfecting during this pandemic

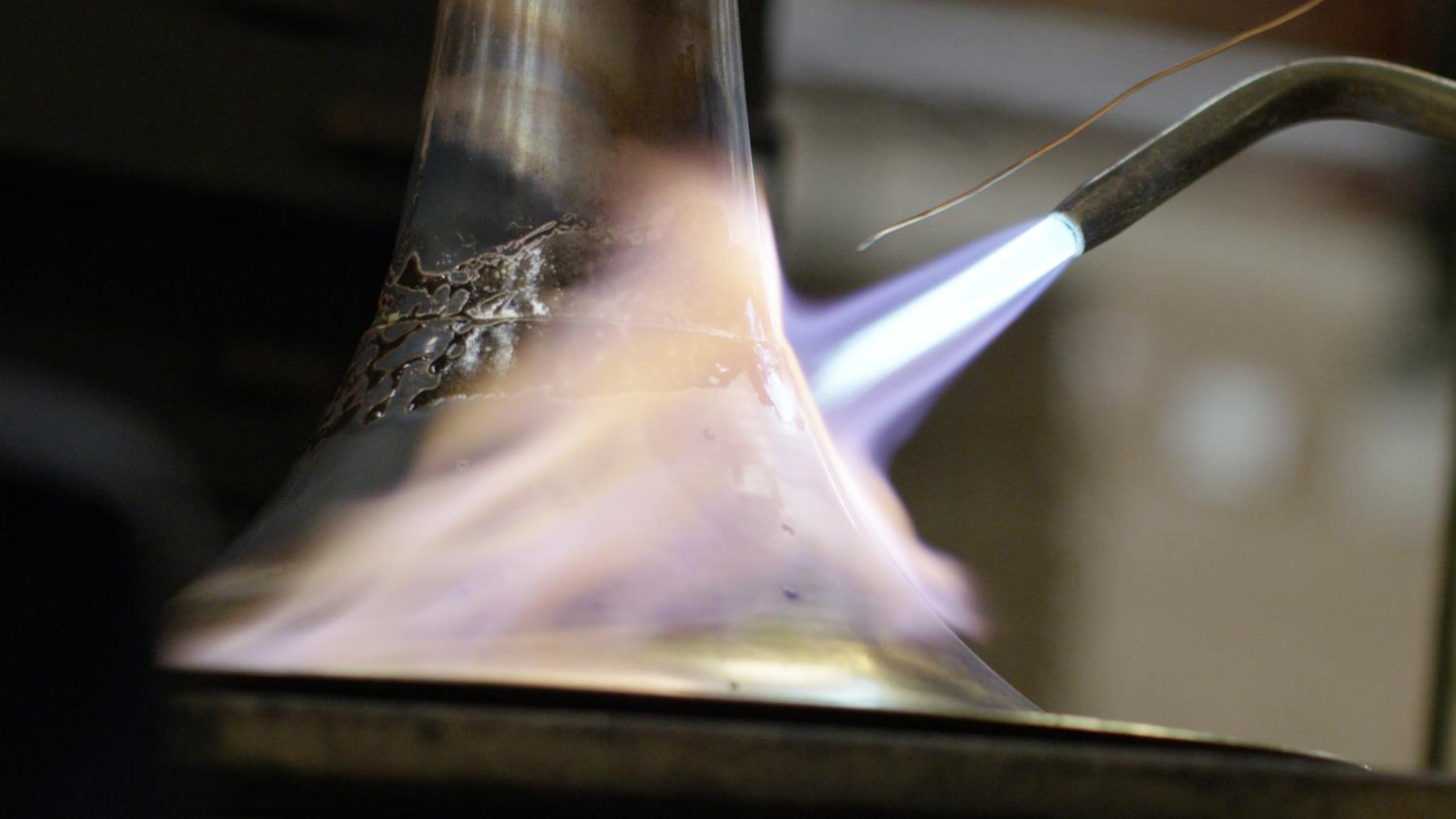
